1. This year's contest will involve **1 ½ blocks of 100% usable ice** for **Artisan** contest categories.
- 2.) **Changes since 2011: The Artisan Division can use hand or power tools! Also, amount of ice for Artisan's changed, reduced to 1 ½ blocks verse 2 blocks as in 2011. The ½ block can be used for the base of your sculpture or incorporated into the sculpture, Artisan's Choice. A complimentary Tee shirt will be provided again for 2012. See "Awards Dinner" form for details.**
3. A sketch of the proposed sculpture and a sculpture title must accompany each application. The sketch will be the primary basis for consideration in the Selection Committee's review of applications for contestant selection, and, upon submission, will become the property of the Saint Paul Winter Carnival.
4. **An entry fee payable to the Saint Paul Festival and Heritage Foundation must be included with this application.** If the entry fee is not enclosed, the entry will not be accepted.

5. Applicants will provide their name and may provide the names of one additional carver and one helper. Refer to the roles of these persons in the rules under "contestant(s)" and "helpers."
